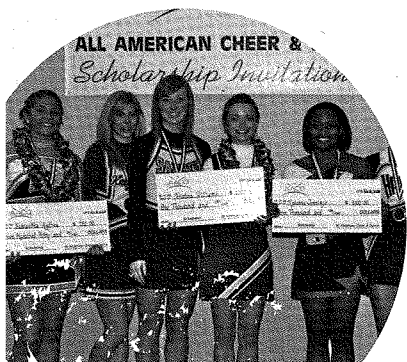

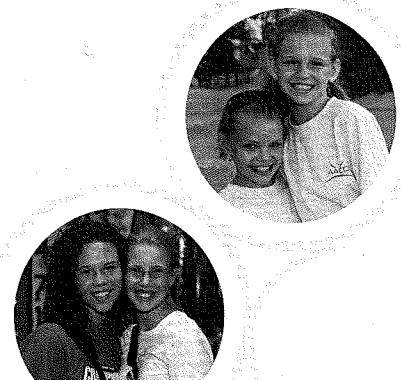

Rules for Travel Agreement

The rules have been established to make the trip safe and enjoyable for everyone. Failure to comply with these rules may result in your being sent home **IMMEDIATELY** with no refund and the participant forfeits all rights and benefits associated with the trip. Any additional expenses will be paid by the participant's parents/guardians. These rules apply to **ALL PARTICIPANTS**, even those traveling with a parent or chaperone. Each participant and participant's parents are required to sign the rules agreement. If you are a participant on this tour you must adhere to the rules regardless of your age. No one is allowed to leave the group without a counselor or designated adult. All participants will be assigned a counselor when they arrive. All participants **MUST** have a signed **GROUP PERMISSION FORM** to accompany other participants in a group to eat, shop, etc. **USE OF ALCOHOL, TOBACCO OR DRUGS IS PROHIBITED.** Dating or fraternizing is not permitted. Cancellation/Refund Policy

Cancellations for any reason prior to October 1, 2008 will be assessed a \$35 cancellation fee in addition to the \$75.00 non-refundable deposit. Any cancellations made from October 2, 2008 through November 1, 2008 will have a 30% fee assessed per ground package in addition to the \$75.00 non-refundable deposit. Cancellations for any reason made from November 2, 2008 through January 1, 2009 will have a 40% fee assessed per ground package in addition to the \$75.00 non-refundable deposit. A fee will also be assessed for any costume/unrecoverable costs incurred by AACD after October 1, 2008. Cancellations for any reason after January 1, 2009 receive no refund; **NO EXCEPTIONS WILL BE MADE TO THIS POLICY.** All cancellations must be in writing and postmarked.
